INTER-MUNICIPAL COOPERATION AGREEMENT

Township School District ('	'MTSD") and the	Hempfield School District ("HSD"	'),
each intending to be legally	bound hereby, en	nter into an Inter-Municipal	
Cooperation Agreement.			

BACKGROUND

MTSD and HSD wish to enter into an agreement to share position of Diving Coach. MTSD and HSD enter into this Agreement pursuant to the provisions of the Inter-Governmental Cooperation Act, 53 Pa. C.S.A. §2301 et seq.

I. **OBLIGATIONS**

- A. Upon ratification of a resolution approving this Inter-Municipal

 Cooperation Agreement by both MTSD and HSD, HSD shall assign
 its Diving Coach, Jenine Nicholas, to coach both MTSD and HSD's
 diving athletes.
- B. The HSD Diving Coach shall remain an employee of the HSD, which will supply any and all compensation to the coach. MTSD shall not be required to reimburse HSD any compensation paid by HSD to the coach.
- C. In consideration for the obligations of HSD under this Inter-Municipal Cooperation Agreement, MTSD shall permit the HSD Diving Team

- equivalent access to MTSD's diving facilities during the MTSD's Diving Team practices. Additional access to MTSD's facilities may be granted by MTSD upon request.
- D. The HSD Diving Coach will provide equivalent coaching and supervision at practices and meets to members of both MTSD and HSD's Diving Teams.
- E. When the Diving Teams compete at two different locations where diving facilities are available, the HSD Diving Coach shall determine which team to coach. Otherwise, the HSD Diving Coach will coach at the one location with diving facilities.
- F. This Inter-Municipal Cooperation Agreement shall terminate upon the earlier of the following events:
 - a) June 30, 2017; or
 - b) Sixty days after written notice by either party of an intent to terminate the Inter-Municipal Cooperation Agreement with or without cause.
- G. Equipment purchased by the HSD shall remain the property of HSD, even though it will be stored at MTHS throughout the season.

H. The parties, upon sixty days written notice, may renew this Inter-Municipal Cooperation Agreement for an additional one year term subject to the terms and provisions set forth above.
