- II. Approval of the November 2022 Meeting Minutes
- III. Sharing SLAC information with PTOs/Parent Advisory Group
 - Some felt they weren't receiving all the information from SLAC.

IV. Follow-up discussion regarding main campus traffic during student arrival & departure

- A parent raised the question about speed bumps if that could deter the speeding in the parking lots.

VI. MTSD North Start Subcommittees – exist in all schools and District Level

- Pathways to Rigorous Curriculum
 - Ensure that students have access to rigorous curriculum and pathways for learning.

- Communications
 - Continue to analyze all aspects of communications at MTSD through the foundation of purposeful and effective communication within and between all school and community members.
 - Disconnect with families that are not English speakers having difficulties understanding the communications coming to them.
- Special Education/Gifted Education
 - Commitment to serve our exceptional and talented students through equitable practices and dismantling barriers that remove over/under representation of sub groups within our student population.

- Comprehensive Plans for both groups and addressing needs.
- VII. PTO Sharing PTO Sharing Reflections & Questions
 - Can they get a Certificate of Insurance (COI) on file with district office since every school is using different vendors but some do overlap.
 - Try to organize communication with all schools to share vendors everyone uses for merchandise.
